# Self-Funding Tuition Fees

Will you be self-funding your tuition fees?  
**What you need to know.**

If you will be self-funding your tuition fees there are some key dates and T&C's which you need to know.

## Tuition fee cost

If you are starting in **January 2024** the tuition fee for an Undergraduate degree is £9,250 per academic year.

## Payment plan

Throughout the academic year (January to December) you will have to pay the full year's tuition fee, the payment deadlines split the tuition fee into three instalments (£3,145, £3,052.50 & £3,052.50). Tuition Fee Payment Deadlines for academic year 2024/25:

First Instalment: 15<sup>th</sup> January 2024 (£3,145)

Second Instalment: 29<sup>th</sup> April 2024 (£3,052.50)

Third Instalment: 01<sup>th</sup> July 2024 (£3,052.50)

## Failure to meet payment deadlines

If you have been identified as a self-funding student and have received a statement of account which will include the payment deadlines mentioned above, you must adhere to the payment deadlines. If you fail to meet the deadline a member of the ARU finance team will get in touch and if no payment is made within 48 hours you will be withdrawn from the course. Under no circumstances will there be any alteration from this.

## Making a payment

For all self-funding students your first instalment must be paid before you can register on your course, thereafter you will be able to make further payments towards your tuition fee at any time after you have completed registration. Payments can be made in person on campus at the Information Desk or online on the VLE in the "My Accounts" area.

## Withdrawing from your course

If at any time you withdraw from your course or decide to leave ARU London under no circumstances will a refund of your tuition fee be paid. If you decide to intermit or defer your entry no refund will be paid and the full tuition fee for that academic year will be due when you recommence your studies.

## Withdrawal tuition fee liability

The amount of tuition fee owed will depend on when the official withdrawal date from ARU London was processed. Any student who withdraws on or before 24<sup>th</sup> June 2024 will be liable to pay 50% of the tuition fee for that academic year. If a withdrawal is processed on or after 25<sup>th</sup> June 2024 the student will be liable to pay 100% of the tuition fee for that academic year.
