Postgraduate Tuition Fees Alumni

What you need to know







If you are accessing the Postgraduate Loan or self-funding your tuition fees there are some key dates and T&C's which you need to know.

Tuition fee cost

If you are starting in If you are starting in **September 2024** the tuition fee is £6,500 for the full course.

Full-time alumni student's payment plan

Throughout the academic year (Sept 2024 – Sept 2025) you will have to pay the full tuition fee, the payment deadlines split the tuition fee into three instalments (£2,166.7, £2,166.7 & £2,166.6). Tuition fee payment deadlines for students starting in Sept 2024:

Full-time (12 Months)

First Instalment: 16th September 2024 (£2,166.70)
Second Instalment: 20th January 2025 (£2,166.70)
Third Instalment: 28th April 2025 (£2,166.60)

Part-time alumni student's payment plan

Throughout the academic year (Sept 2023- 2025) you will have to pay the full tuition fee, the payment deadlines split the tuition fee into six instalments (Year 1 - £1,084, £1,084, £1,082, Year 2 - £1,084, £1,082). Fee payment deadlines for students starting in September 2023:

Part-time (24 Months)

First Instalment: 16th September 2024 (£1,084) Second Instalment: 20th January 2025 (£1,084) Third Instalment: 28th April 2025 (£1,082)

Fourth Instalment: 15th September 2025 (£1,084)

Fifth Instalment: 12th January 2026 (£1,084)

Sixth Instalment: 13th April 2026 (£1,082)

How to pay your fees

Your tuition fees are paid through a recurring card payment plan, please refer to your "ARUL Postgraduate Tuition Fee Payment Plan" for payment details. This payment plan must be completed and signed to formally complete registration onto the course. Cancelling this agreement will be taken as a withdrawal request from your course of study.

Withdrawal tuition fee liability

Full-time students

The amount of tuition fee owed will depend on when the official withdrawal date from ARU London was processed. Any student who withdraws on or before 15th January 2025 will be liable to pay 33% of the total tuition fee. If a student is still registered on the 16th January and then proceeds to withdraws on or before 29th May 2025 they will be liable to pay 66% of the total tuition fee. If a withdrawal is processed on or after 30th May 2025 the student will be liable to pay 100% of the tuition fee for that academic year.

Part-time students

The amount of tuition fee owed will depend on when the official withdrawal date from ARU London was processed. Any student who withdraws on or before 15th September 2025 will be liable to pay 50% of the total tuition fee. If a withdrawal is processed on or after 16th September 2025 the student will be liable to pay 100% of the total tuition fee.
