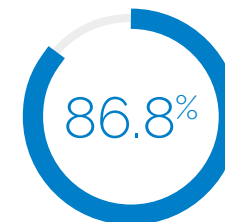

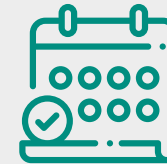
## Your timetable



### 2 day timetable

## Your attendance

If you're new to the London commute, you'll soon realise that throughout your study, the costs quickly add up. All of our undergraduate students are eligible for a student support bursary.

### To be eligible for the Student Support Bursary, you will need:

- To be studying an undergraduate degree
- 80% minimum attendance across all modules for the semester
- To submit all assessments on time

If the above requirements are met at the end of trimester 1 and trimester 2, two separate payments of £250 will be paid into your bank account to support travel costs at the end of each trimester.

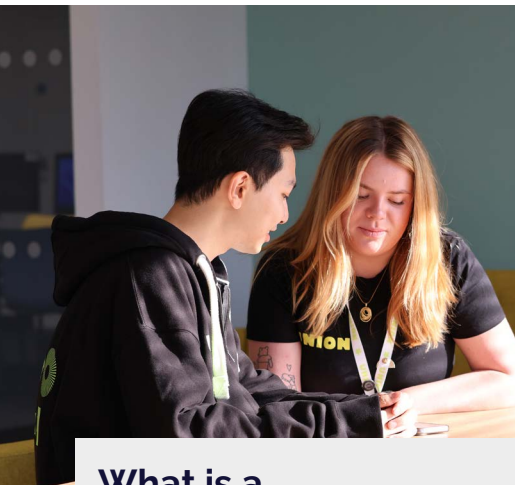

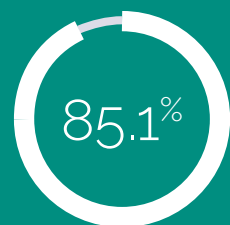

Remote controlled cameras and microphones that allow all seminars and lectures to be live streamed.

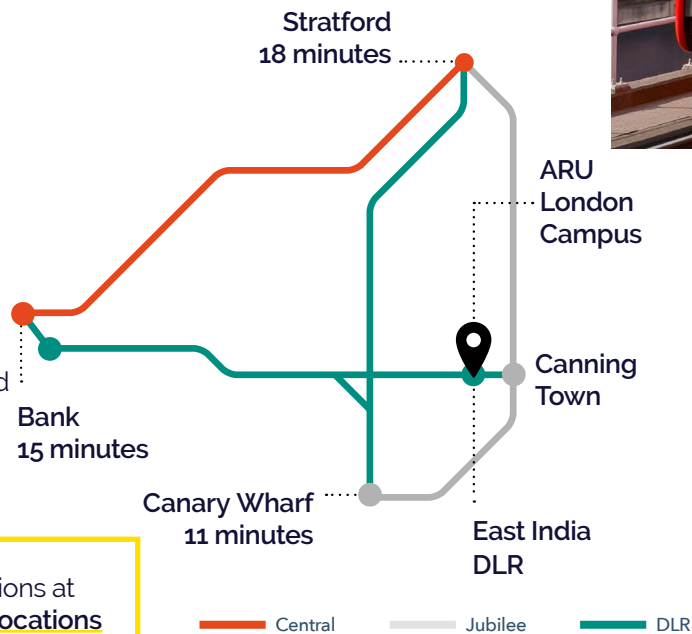

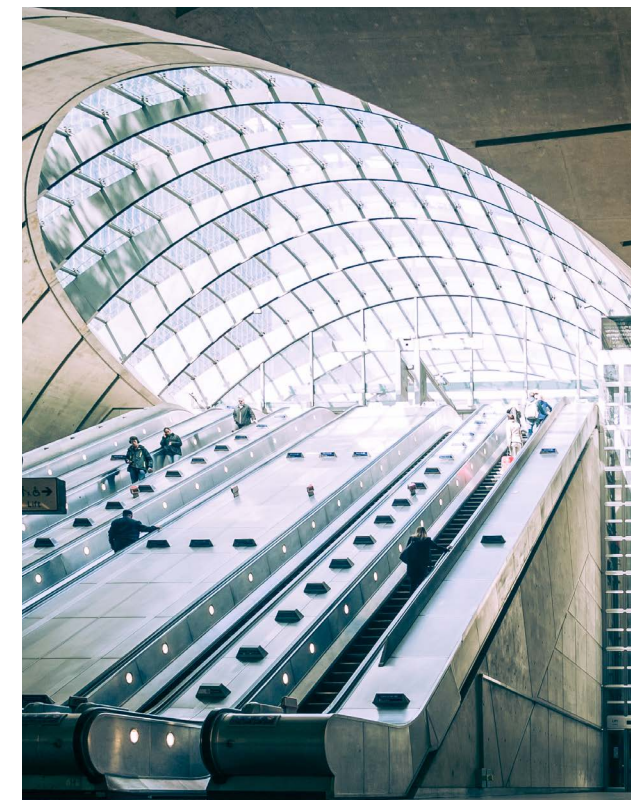
## East India

East India – Import and Export Buildings, 2 Clove Crescent, Poplar, London, E14 2BE

East India DLR station is situated on-site, just a few minutes' walk from the platform to the classroom. Using the DLR from East India, you can arrive in Canning Town in 2 minutes (Jubilee Line), Canary Wharf in 5 minutes (Jubilee Line and Elizabeth Line), and Stratford and Bank in 13 minutes (Central Line, Jubilee Line, Northern Line, London Overground, TfL Rail and Greater Anglia rail services).

The hospitality and events industry is a dynamic, people-driven global sector and the UK's third-largest employer, supporting over 3.5 million jobs and generating around £55 billion in annual tax revenue. As the industry evolves post-pandemic, demand is growing for graduates with strong business acumen and specialist operational knowledge.

At ARU London, this course combines business management with hospitality and events expertise, balancing theory, practice, and professional development. Through engaging modules and a live event project, you'll develop leadership, teamwork, and problem-solving skills while gaining insight into how global organisations operate and deliver successful, sustainable experiences in the UK and internationally.

# BSc (Hons) Business and Law



## About this course

This intellectually stimulating course addresses broader aspects of business organisation and management culture, while also providing an insight into corporate and consumer legislation, corporate regulation and other legal aspects of business enterprise. You will be equipped with a real understanding of how legal considerations impact virtually every aspect of management activity.

Employers look for business graduates with knowledge and awareness of current issues. This course will teach you about globalisation, sustainability and social change, allowing you to fully understand the factors affecting business. When you graduate, you will have a sound appreciation of management practice. This will include human resources, marketing, business law and information management. You will also learn the skills to analyse strategic consumer behaviour.

## Careers

The skills you gain from this course will also open opportunities for you in many other professions, including banking, commerce, local and central government, and teaching.

## About this course

Britain's tourism sector is a major economic force, generating £106 billion annually and employing over 2 million people. It plays a central role in the UK's visitor economy and is a key focus in government plans for future growth, supported by national agencies like Visit Britain/Visit England. As the sector continues to expand, there is strong demand for graduates who understand tourism management and have practical business skills.

This course is designed to equip students with those essential skills, while exploring the current challenges facing the industry, such as sustainability, global issues, ethical tourism, competition, and crisis management. It aims to enhance your commercial awareness and specialist knowledge, preparing you for a successful career in this dynamic and growing field.

## Careers

In your third year, you will undertake the Tourism and Events Live Project which will enable you to integrate your academic knowledge with experiences beyond the classroom and combine your developing knowledge to expand transferable skills which can be applied in the workplace. Your lecturers all have first-hand experience in business and hospitality. You are therefore assured that the content of your degree will be directly relevant to the demanding, constantly evolving world of business and tourism.

## About this course

A degree in Finance and Accounting offers valuable knowledge and skills for various careers within the business world. Whether your goal is to become a qualified accountant or explore other business roles, this degree provides a solid foundation.

Successful completion of the Finance and Accounting course provides the highest level of exemptions, covering a total of 9 foundation papers for students who are already considering obtaining a professional accounting certification, such as the ACCA (Association of Chartered Certified Accountants).

Whether you want to move into auditing, financial reporting, management accounting or financial services, this could be the course for you. You'll develop subject-specific skills alongside important transferable skills like communication, enterprise, problem-solving and quantitative analysis.

## Careers

During your studies, you will have opportunities to enhance your future employment prospects through careers support, including CV guidance, interview preparation, career advice, and engagement with employers.

## About this course

At ARU London, you can take your first step towards becoming a solicitor or barrister, as our course will qualify you for the next stage of your legal training. You will study both academic and practical aspects of the law, which not only prepare you for a legal career, but will also give you many skills that are highly valued in other occupations.

As you go through our core modules, you'll be developing key knowledge of fundamental features of the UK and EU legal systems, and the context in which the law operates. All this while engaging in critical analysis with peers, solving legal problems, and undertaking independent research, flexing your ability to construct complex legal arguments.

## Careers

If you want to proceed to the vocational stage of training as a barrister or solicitor (Bar Professional Training Course), this LLB is your first step. You might also choose to work in private practice as a paralegal, carrying out many of the tasks and roles of a qualified solicitor.

Our students go on to a wide range of careers. Some, of course, go on to the next stage of training to become solicitors and barristers. Others go on to work as paralegals, and others use their LLB in a variety of other professions, including banking, commerce, government, and teaching.

**Career Routes:** Barrister, Barrister's Clerk, Chartered Legal Executive, Company Secretary, Solicitor, Patent Attorney, Data Analyst, Human Resources Officer, Civil Service.

Graduation with a 2:2 or above with a degree covering these subjects is required by the Bar Standards Board for entry to the vocational stage of training to become a Barrister. Our LLB also covers the subjects which are examined by the Solicitor's Qualifying Exam 1 (SQE 1); the first step in professional training to become a Solicitor.

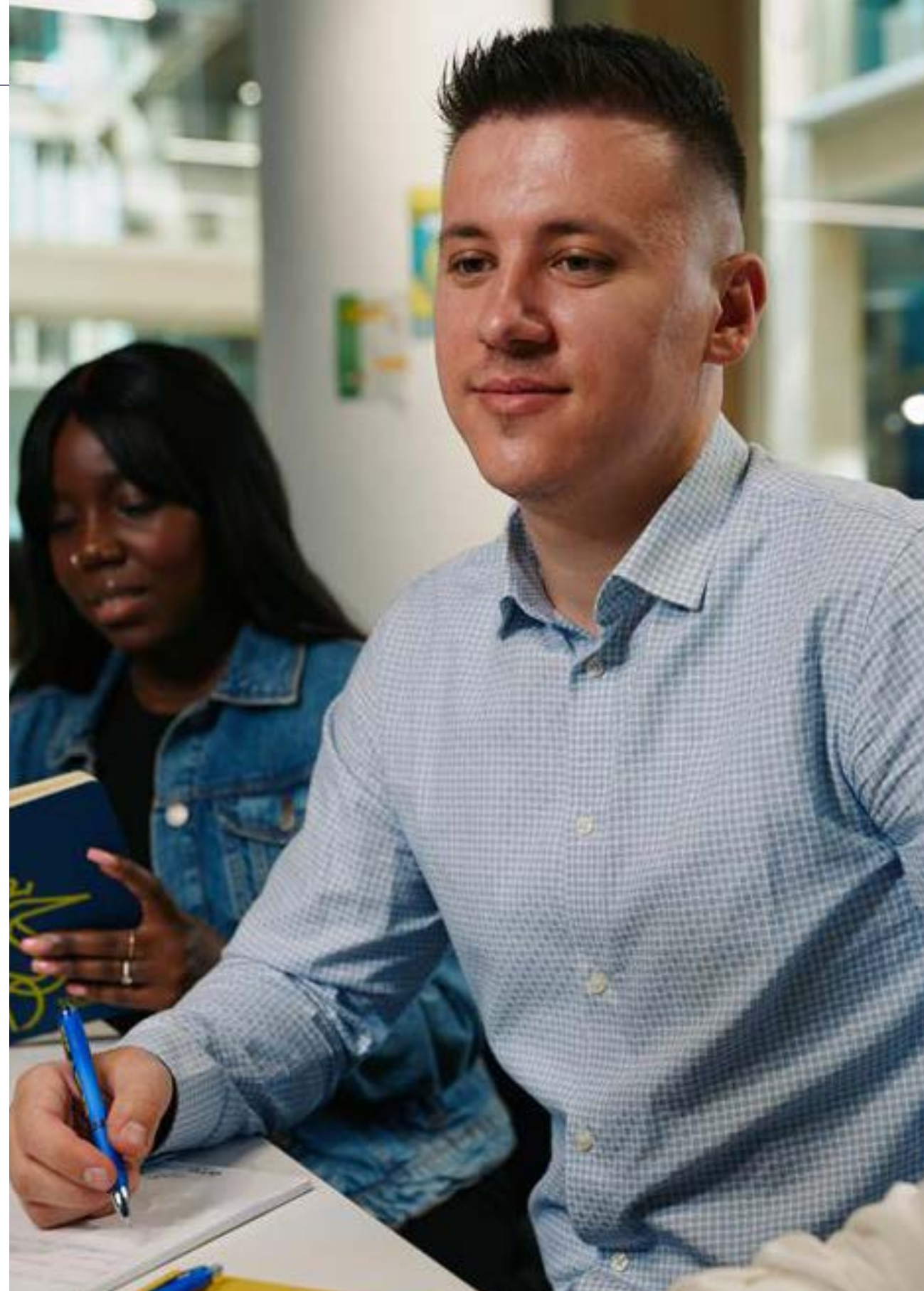

## About this course

In an increasingly connected world, with average levels of disposable income on the increase, Hospitality and Tourism have become vital sectors to national economies. This course is designed for those looking to move into senior management positions in the Hospitality and Tourism sectors within an international context. The course includes core topics around marketing, branding, and the use of digital platforms, along with human capital management issues and the changing patterns of the available talent pool across national boundaries. The course is assessed by a variety of methods, including written coursework, presentations, and workplace simulations.

## Careers

Developed in conjunction with leading industry experts, this degree uses innovative learning strategies to enable students to empower themselves with the future skills required to lead major enterprises in the international hospitality and tourism industries. 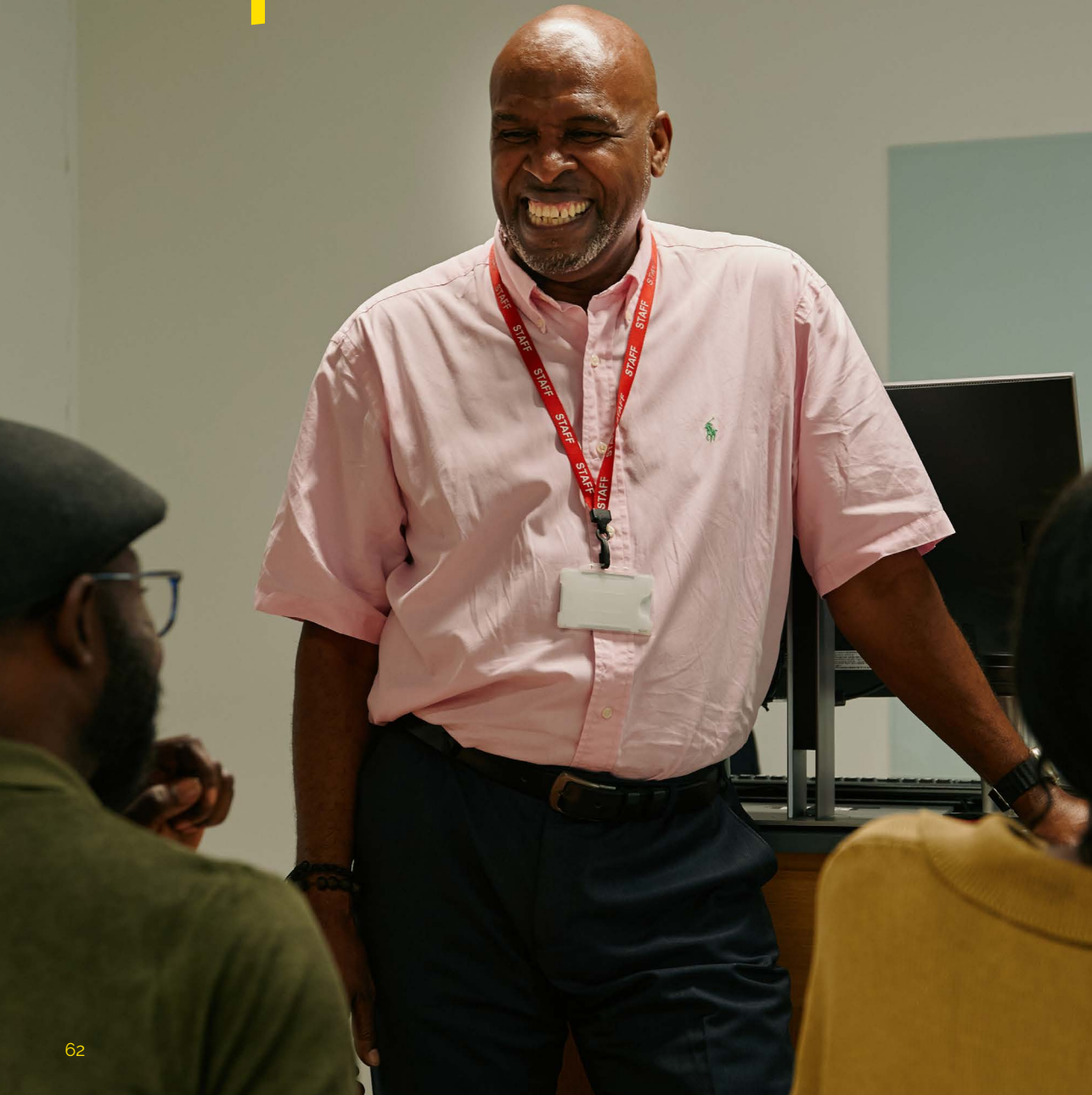

We treat everyone as an individual which means we will look at your whole application, including any relevant work experience and personal circumstances, as well as your educational qualifications.

## English language requirements

To demonstrate proficiency in English language, ARU London recognises several formal tests. ARU London have partnered with Password and Duolingo to deliver computer-based English Language Tests.

For the Password test, applicants must achieve an average of 6.0 with 5.5 in each sub-test for an undergraduate degree and 6.5 average with a minimum of 5.5 in each sub-test for a postgraduate degree.

For the Duolingo English Test, applicants must achieve an average of 100 for undergraduate entry and 110 for postgraduate entry, and no less than 90 in all sub-scores (Literacy, Conversation, Comprehension, Production).

### Who do you want to live with?

Create a minimum and maximum figure of the amount you are willing to pay for rent and bills. This will help make financial decisions when weighing your options.



### Near or far

Know what type of place you want to live in and what area. Check out how easy it is to commute to the campus and back, and how close you are to amenities, such as shops and healthcare practices.

### Making time

Unless you are happy to relocate multiple times, remember to keep in mind that you will need accommodation for however long you are studying.

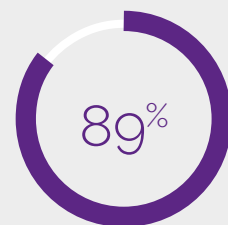

\*Tuition fees vary for each course. Please refer to the relevant course page for the specific fee details.

## Student loans

As a student, you are eligible for loans from Student Finance England to support you while you study; together these are your student loan. Your student loan comprises a tuition fee loan and a maintenance loan, and a postgraduate loan if applicable.

If you are starting your first undergraduate degree in 2026/27, you'll be on Plan 5 for your student loan. For this plan, you won't repay any of your loan back until you earn over £25,000 per year pre-tax.

The threshold for how much you need to earn to repay your loan changes annually in April. This information is correct as of January 2026 but is subject to change.

## Tuition fee loan

Tuition fee loans are obtained from Student Finance England and are used to pay the cost of your tuition fees.

You can apply for a Tuition Fee Loan through Student Finance England.

## Maintenance loan

As well as a tuition fee loan, you can apply for a maintenance loan from Student Finance England too.

The maintenance loan you receive depends on:

- Where you live when studying
- Your family household income



### Postgraduate loan

The postgraduate loan (PGL) is a loan of up to £12,858 for new postgraduate students starting on or after August 2025. You may be eligible for a PGL if you:

- Are aged under 60 on the first day of the academic year.
- Don't already hold a master's qualification (or equivalent or higher-level qualification, i.e. a Doctorate).
- Are a UK National or individual with settled status in the UK or ordinarily resident in the UK and Ireland for 3 years on the first day of the first academic year of your course.
- Are an EU national, have the residency status of refugee, humanitarian protection, EEA or Swiss migrant worker, or a family member of any of the previous categories or a child of a Swiss national or Turkish worker.

You will be able to apply for a PGL on the Student Finance website. If you already have an account with Student Finance England from an undergraduate loan, you should use this to apply for your PGL. If you are eligible for the PGL, it will be paid directly into your UK bank account in three equal instalments each academic year.

You will not start paying back your postgraduate loan until you pass the threshold of earning over £21,000 per year pre-tax, as of March 2025.

### EU Applicants

As of 1st of August 2021, you must have a settled or pre-settled status under the EU Settlement Scheme to apply for student finance.

### Grants and extra support

Depending on your circumstances, students can gain further governmental support such as:

- Universal Credit
- Childcare Grant
- Parents' Learning Allowance
- Adults Dependants' Grant
- Disabled Students' Allowance and disability-related support
- Advanced Learner Loan

## Undergraduate scholarships

We offer scholarships before, during and after your undergraduate studies.

### Entry Scholarship

We encourage all of our new applicants to apply for our Entry Scholarship.

**£1,000 off** first-year fees for eligible new applicants who meet the following criteria:

- 144 (AAA) UCAS points (UK/EU) or
- A+ grade or a minimum of 80% or GPA 5.0 in your A-Levels or equivalent qualifications (international students)

### Top Achievers

**£2,000** scholarships for overall top achievers in **Year 0** (foundation year), **Year 1**, and **Year 2**, applied to tuition fees for the following academic year.

### East London Boroughs Bursary

**£500** per academic year for eligible full-time undergraduate students from selected East London boroughs, subject to household income and Student Finance England means testing.

## Postgraduate scholarships

### Entry Scholarship

Similar to our undergraduate Entry Scholarship, we offer a Postgraduate Entry Scholarship with **£1,000** off your entire course fee if you achieve a First Class honours degree from a university in the UK.

### Master's Scholarship Programme

Each year, we provide several scholarships throughout our **3** intakes. The successful applicants will receive **50% off** their tuition fees, a scholarship worth **£4,250!**

To apply, applicants must write 750+ words on why they wish to study for a postgraduate degree at ARU London.

### Alumni Scholarship

If you graduated with an undergraduate degree at any ARU campus, we offer **£2,000 off** your entire course fee when you enrol as a postgraduate student with us.

Please note that only one scholarship can be applied per student. The scholarship with the highest value will be taken into consideration.
